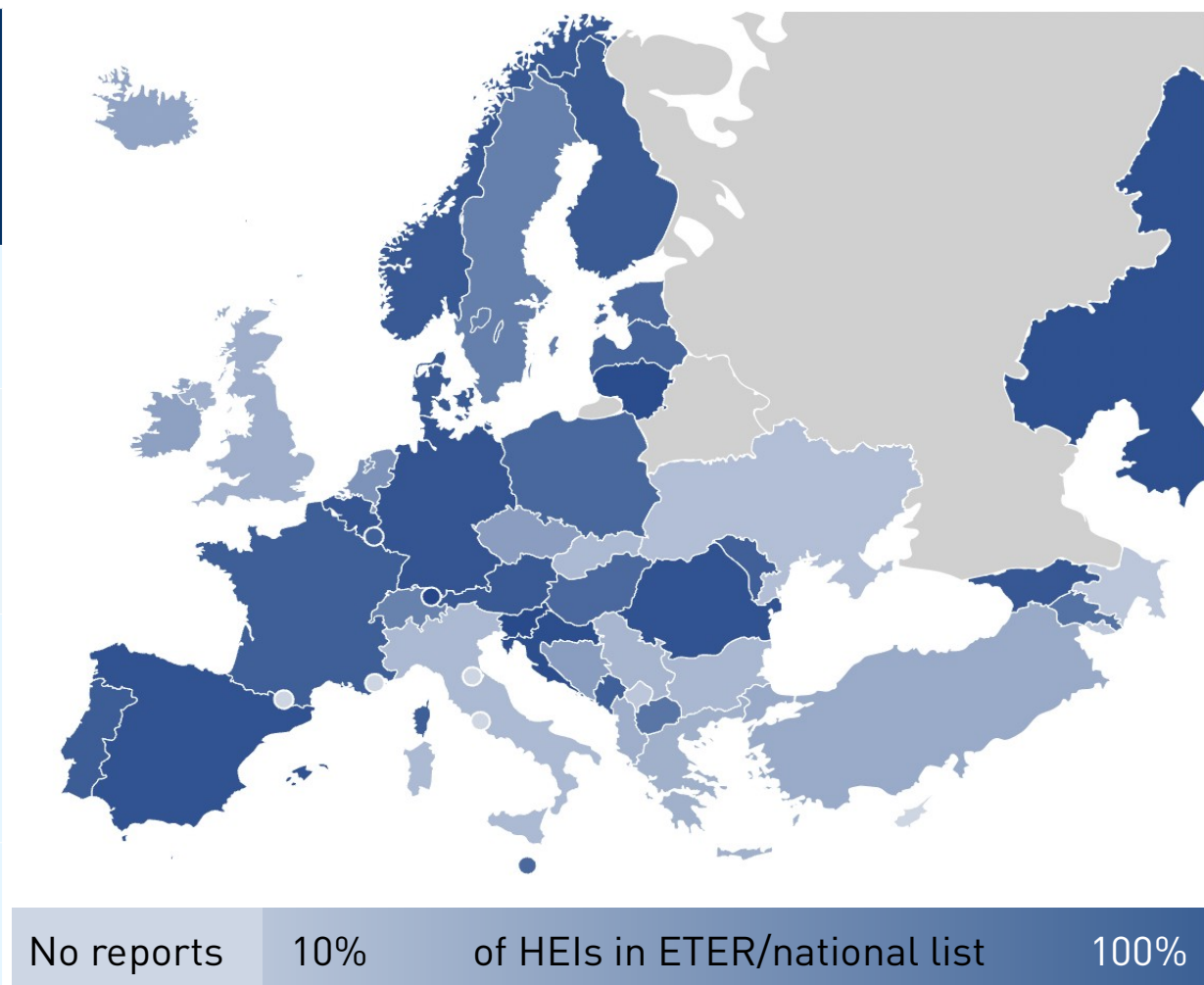

- * Other identifier (e.g. VAT number) and identifier source as obligatory fields (*)

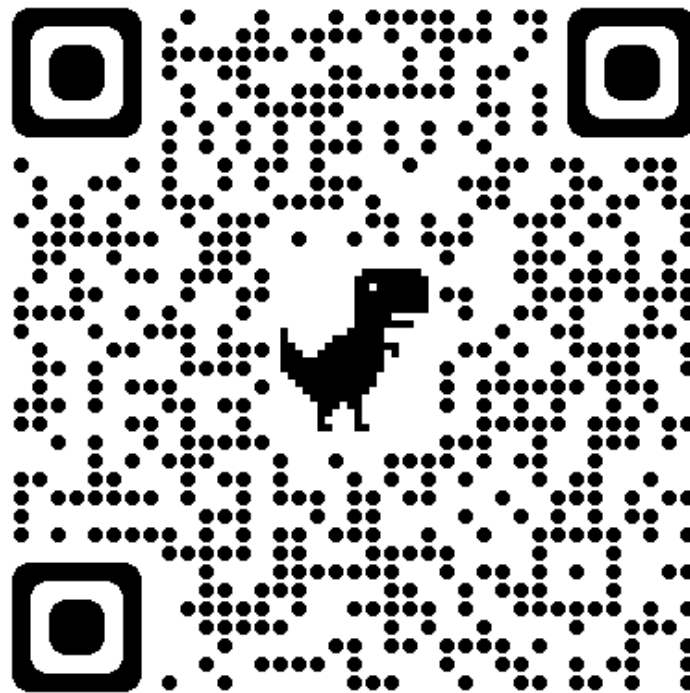
- **New fields**
